# Our Mission, Our Task

*Tarrant County Homeless Coalition provides leadership to prevent and end homelessness*

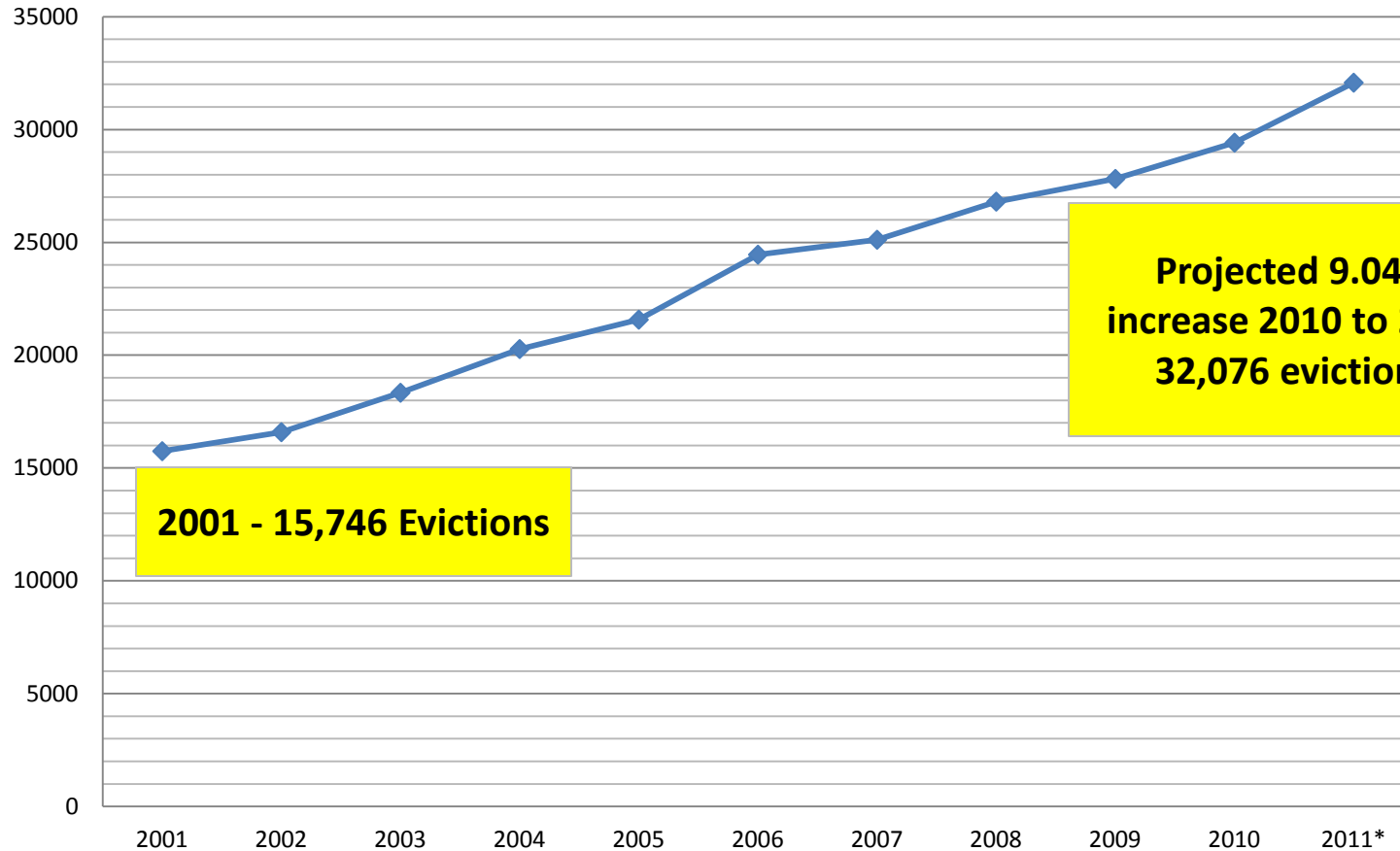
- TCHC collects and analyzes eviction data from Tarrant County as an indicator of potential new homeless and the need for homeless prevention activities
- TCHC collects and reports data from the Homeless Prevention and Rapid Rehousing programs funded from the American Recovery and Reinvestment Act of 2009 (ARRA)
- TCHC collects data and conducts official census of the persons experiencing homelessness

# Evictions in Tarrant County

- Between 2001 and 2011, evictions are projected to more than double
- Between 2010 and 2011 through the end of September, evictions have increased by over 9% - the highest one year increase since 2005/2006
- Data provided from January 1, 2011 through September 30, 2011

# Evictions and Homelessness

## 2011 TCHC Homeless Survey:

- 44 of the 1,184 surveyed during the January 27, 2011 homeless count responding to the question of how they become homeless stated they had been evicted **within the past week**
- 51% (604 of 1,184) said that their inability to pay the rent lead to their homelessness

# Preventing Homelessness

The ARRA, through the HPRP program, provided funding for rents and utilities to keep persons facing eviction in their homes and rapid housing placement for families who became homeless

- Programs began in October 2009
- Local and State governments distributed these funds to agencies to administer the HPRP programs to qualifying families and individuals

# Homeless Prevention Rapid Rehousing IMPACT

**1,894 households 4,583 persons – 46% children**

- Stabilized Housing for families with direct rental assistance
- Allowed participants to clear rental and utility arrearage
- Increased participants' financial literacy
- Increased participants' enrollment in benefits (e.g. TANF, food stamps, unemployment, SSI/SSDI)
- Provided case management
- Aided participants in seeking and completing training

# Ramping Down HPRP

The work ahead for TCHC and the CoC:

- Assure participants are well informed of the end of the programs and are linked to any needed continued supportive services
- Data analysis to understand the rent burden, household demographics, benefit / employment income of families at risk of homelessness
- Review all outcomes from HPRP to identify the most successful programs

# Ramping Down HPRP

The work ahead for TCHC and the CoC:

- Finding new funding for the best components of HPRP programs, training and case management
- Track any former HPRP households who fall into homelessness down the road
- Profile the most at risk household types and target for new HUD Emergency Solutions Grant RFPs in 2012

# Homelessness During HPRP Program

- Approximately 4,487 will experience homelessness in 2011
  - Homelessness has decreased slightly
  - Chronic unsheltered homelessness has decreased markedly

- *Persons and Families that are doubled-up are not included in the official homeless census*

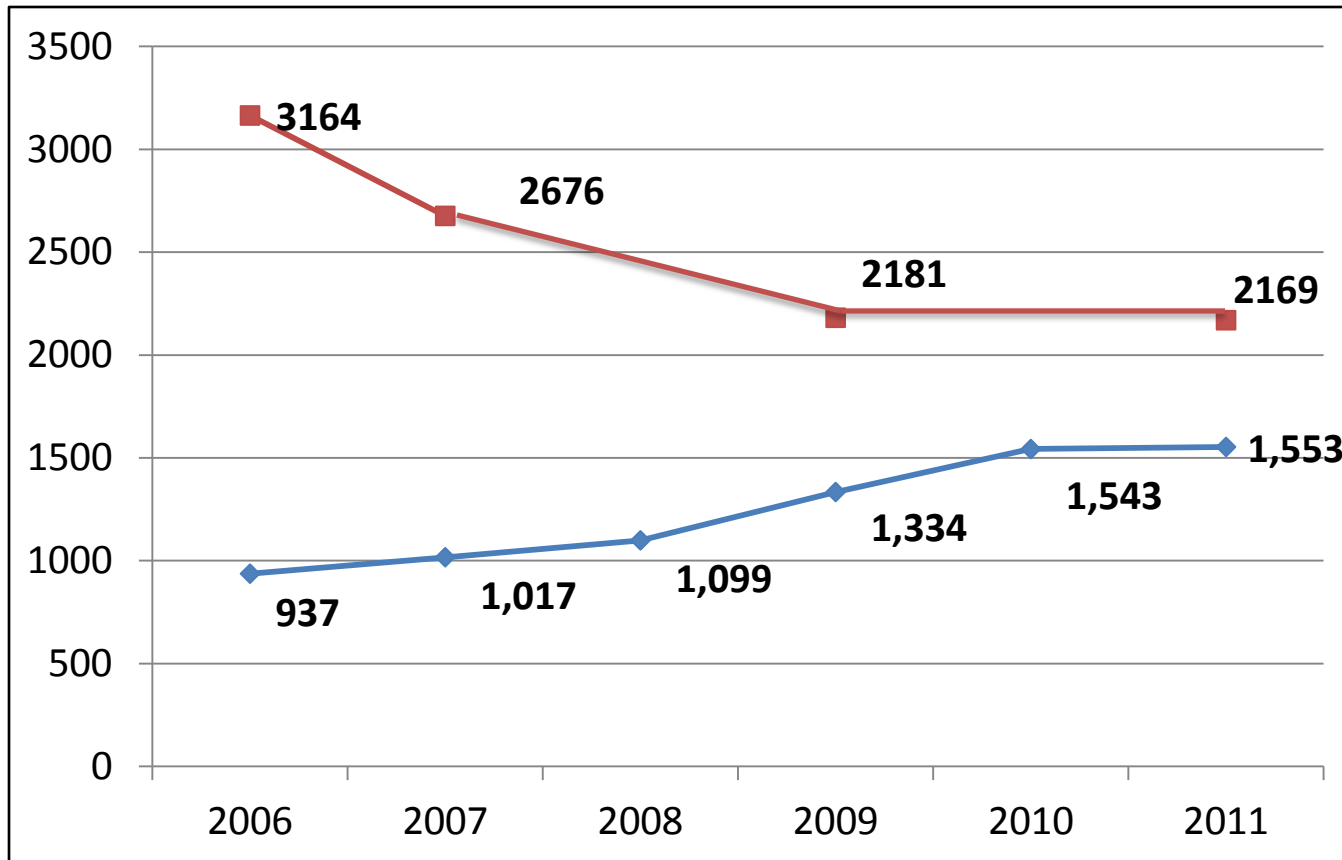

# Homelessness During HPRP Program

- The creation of new permanent supportive housing units has a direct correlation to the decrease in chronic and unsheltered homeless

# Families with Children in Homelessness

- HPRP primarily served families facing eviction
- There are only 388 emergency shelter housing beds for persons in families, 150 are restricted to domestic violence victims
- Family Emergency Shelters now have waiting lists
- The CoC is adding family beds to its inventory of Permanent Supportive Housing
