The CoC has experienced an increase in family homelessness and will increase RRH beds to relieve the over-crowding in emergency shelters. The CoC has received additional VASH vouchers to a total of 290 to address chronic homelessness among Veterans. The CoC Board of Directors passed a policy on January 15, 2014 to dedicate through natural attrition 85% of the CoC Program funded beds to the chronically homeless. New non-CoC funded beds, will be funded through the Texas Department of Housing and Community Affairs to fund up to 40 new beds for the most vulnerable homeless. The new Coordinated Assessment System that will go live April 1, 2014, will provide verification that the chronically homeless will be prioritized for PSH beds made available through turnover and all new PSH.
