 - **CONVERT THE eSNAPS APPLICATION TO PDF AND INCLUDE WITH YOUR RFP SUBMISSION**

Additional Required Documents

- Additional Required Attachments/Forms
 - Form HUD-50070: Certification for a Drug-Free workplace dated **no earlier than July 1, 2015**
 - Form HUD-2991: TCHC will complete
 - Form HUD-2880: Applicant/Recipient Disclosure/Update Report must be attached for each project
 - Must include the correct amount of HUD assistance requested and must be dated between **July 1, 2015 and November 20, 2015**

Renewal Applications

- Budget line item totals **can not** change from the HUD approved [Grant Inventory Work \(GIW\) sheet](#)
 - You are **not** allowed to increase your established admin rate approved in the GIW
